Our employees receive training on the importance of ethics and their role in upholding our commitment to our principles. The Company is committed to transparent and integrity-driven communication regarding the integration, compliance, and identification of violations and the mitigation and remediation actions it undertakes, ensuring a secure and healthy relationship with our Suppliers and employees.
